### 2020–2021 Non-Filer Statement—Student

Your FAFSA has been selected for verification by the U.S. Department of Education. **NOTE:** You are required to file an IRS Income Tax Return if you earned over \$12,000.00 for the year. attesting

**IMPORTANT:** Do not include financial aid received in 2018.

**If you earned income in 2018, list the source and amount of all income received for 2018 in the table below.** Each entry requires proof of income, i.e. a W2 or 1099. *Important: financial aid does not count as income.*

**If you did not earn income in 2018,** list \$0 in the Total field. Independent students must supply a “Verification of Nonfiling Letter” from the IRS dated on or after October 1, 2018, attesting that you did not file a 2018 income tax return. This form is required by completing IRS Form 4506-T and checking box 7. Persons subject to foreign countries tax codes would submit comparable documents.
